## Membership Payment Schedule

<b>Personal</b>	<b>\$50.00</b>	Shall mean one who is not in the business of trade or commerce and who derives his livelihood from a wage or salary. Each member in this category shall be entitled to one vote in the affairs of the Chamber.
<b>Home-based Business</b>	<b>\$70.00</b>	Shall mean one who is in the business of home-based trade or commerce and who derives all or part of his livelihood from this home-based business, and does not employ workers. Each member in this category shall be entitled to one vote in the affairs of the Chamber.
<b>Business</b>	<b>\$110.00</b>	Shall mean one who is in the business of trade or commerce, and who may or may not employ workers. Each member in this category shall be entitled to one vote in the affairs of the Chamber.
<b>Institution</b>	<b>\$110.00</b>	Shall mean Township, Improvement District, Hospital, Local Roads Board, and any Federal or Provincial agency which employs no less than ten people and whose office is located in the district. Each member in this category shall be entitled to one vote in the affairs of the Chamber.
<b>Private Corporation</b>	<b>\$110.00</b>	Shall mean an entity which employs workers, is incorporated under Provincial and/or Federal laws, and is privately owned. Each member in this category shall be entitled to one vote in the affairs of the Chamber.
<b>Public Corporation</b>	<b>\$260.00</b>	Shall mean an entity which employs workers, is incorporated under provincial and/or Federal laws, and whose shares are traded on one or more Stock Exchanges. Each member in this category shall be entitled to two votes in the affairs of the Chamber.
